- Baltimore City Schools – 27 completed, 2 schools in construction.
- Built To Learn – MOUs with 16 counties representing 38 projects.
- Racing –Permit process is underway.
- CORE: 1,303 notices to proceed; 1,285 properties completed and turned over to Baltimore City. Mr. McGuigan is a member of a council with a goal to increase the demolition of vacant Baltimore City properties at an increased speed and efficiency.
