### **On-Call JMT CM Services Agreement (revision)**

Mr. Tyler explained the need for, and recommended approval of the revision of the contract with JMT in order to assist The Department of Natural Resources in hosting the inaugural Fair Hill 5 Star competition, October 15-17 of 2021. There are items that are required for a successful event. Given remaining project funds, critical nature of the identified additional items and extremely aggressive timeline, DNR requested that MSA assist in the design, procurement and execution of the work. This resulted in an extension of the bidding and negotiation period. After extended outreach efforts, JMT was able to compile a GMP for the complete scope of services, though competition was limited and MBE participation fell below the goal of 10%. The current GMP cost, inclusive of the preconstruction services efforts is\$856,810 and includes \$29,950 in MBE participation.

- Racing Projects Initiative: Continues planning and programs.
- DLS Building: Design is almost complete and construction starts after the 2022 legislative session.
- Ocean City Convention Center: Viewed progress while attending MACO, construction is on schedule for the end of 2021 opening.
- CORE: 1090 notices to proceed; 894 units demolished; remainder in demolition or HAZMAT.
- Baltimore Convention Center: East side study is approaching completion.
- Hagerstown Multi-Use Sports and Events Facility: Property acquisitions are underway. Will have design/build RFP should be released next week or two.
